#### A) President's Report – Pat Hallahan

Health Benefits – The two unions are working on this issue, as is the Ontario College Retirees' Association (OCRA). We had a Clarica Representative speak to retirees but there has been no follow-up. Sun Life compares favourably to other plans but it is expensive and is geared towards full time employees. We will continue to study the issue. The next newsletter will have the CARP (Canadian Association of Retired Persons) plan in it.

Con Ed fees – the Aqua fitness is \$10 but most general interest courses that retirees would like to take are not on the \$10 list. We will continue to work on this problem. Art Collection – is completed and now on a CD. We would like to remove the collection that is in storage and get it on the walls of the college.

Education Committee – We would like to offer seminars and mini courses for our retirees on topics such as tax tips, travel insurance, Excel etc.

Memorial Plaques – The College is redoing the wall of plaques for a consistent look, which will include our memorial plaque.
