## 4. Membership Report

Anita Blair reported that there are 426 members in the database. Of these, 394 are college retirees and 32 are Associate Members – the cafeteria ladies, staff who left the college before retirement, and spouses of deceased members. For 2007, we have 237 paid up members – 215 retirees and 22 Associate members. The annual fees collected are matched by Dr. Strasser. Paid memberships have shown a significant increase since we started sending a return envelope with the annual fee notice.

Members from the Windsor Chapter of the Retirees joined the Thames Chapter for a luncheon meeting in September at the Lighthouse Restaurant, Lighthouse Cove and for the RM Classic Cars Tour on October 25, 2006.
