The purpose of this well-intentioned legislation is to protect the general public from unwanted emails. However, it also carries with it some unintended negative consequences.

The most significant of these has been in the method required to forward emails from other sources, such as those which promote College events. A once 3 step process is now closer to 20 steps. This has been a great source of frustration for yours truly; fortunately, recent retiree Ken Garber has come to the rescue.

The new system does allow for grouping of emails, such that we can now forward to just Windsor or Chatham-Kent or those outside the area. We can now also identify which emails are of interest to our readers; this may result in even more refining of our groupings.

#### MEMBERSHIP COORDINATOR'S REPORT- Anita Blair, Membership

As of this writing (April 1/15) we have 266 paid up members and associate members for 2015. We have followed our standard practice and sent out a second reminder with the Spring newsletter to members who paid in 2013 or 2014 but not for 2015. Dr. Strasser has again agreed to match our membership dues. Our dues remain at the low price of \$10.00 which has never been raised. Although the Executive has had numerous discussions, we do not have a life time membership fee.
